Dear Stream Team Volunteer Water Quality Monitors,

Enclosed is the 2018 Volunteer Water Quality Monitoring Validation Training Schedule.

Data submitted by Level 2 and above Volunteer Water Quality Monitors are utilized at a higher level and are often used to supplement agency data. To ensure we are providing the highest quality data to the sponsoring agencies and all other data users, the Program requires individuals to have their equipment checked at least once every three years in order to maintain quality assurance and confidence in data collected by Level 2 and above volunteers.

Monitors can attend either a Level 2 training or a VWQM Validation Training. This training is critical to ensure that the volunteers' equipment is functioning properly and their reagents are viable.

In order to be eligible to attend, you must have previously completed at least a Level 2 workshop. The focus of these workshops will be Quality Assurance/Quality Control (QA/QC) procedures to improve the quality of volunteer data.

The entire workshop will be held indoors. We will spend time analyzing water samples using the chemical equipment you were issued, so bring all monitoring equipment (*including colorimeters, kick net, and ensure your pH meter is properly hydrated just before you attend*). Also bring any expired reagents for replacement and proper disposal. We will spend time improving your macroinvertebrate identification skills followed by a short evaluation to help establish baseline information on the accuracy of volunteer biological data.

You will receive a confirmation letter and directions after the registration deadline date. Class size will be limited to 15 people per workshop and is filled on a first-come, first-serve basis. *Individuals under 18 years of age must be accompanied by a sponsoring adult to attend.*
